# I am pleased to present my Annual Report for 2024.

- to liaise with the general manager on: the activities of the Council and the performance and exercise of its functions and powers; and the activities of the general manager and the performance and exercise of powers in supporting the Council.

### **Constituent correspondence and meetings**

Over the period this Report covers, the Office of the Lord Mayor directly received and responded to 782 pieces of correspondence – via email and letter – on a variety of issues of concern to the citizens of Hobart. Some of these queries and issues were able to be handled by research, discussions with City staff experts, or referrals to more appropriate agencies.

Occasionally the correspondence raised more complex issues. To this end, Lord Mayor Reynolds met with 34 constituents, both at the Town Hall and at on-site visits.

### Mayor in the Chair

Lord Mayor Reynolds regularly meets with City of Hobart residents via her "Mayor in the Chair" sessions. These drop-in sessions are an opportunity for community members to ask questions or raise issues directly with the Lord Mayor in person without needing to make an appointment. The sessions usually take place in the Henry Hunter Room at the Hobart Town Hall and also in suburban cafes around Hobart. Over the period of this Report, seven Mayor in the Chair sessions were held.

### **Citizenship ceremonies**

The City of Hobart holds citizenship ceremonies on behalf of the Australian Government and Lord Mayor Reynolds presides over the ceremonies. Over the last year, the City of Hobart conducted four ceremonies where 360 people became Australian citizens.

### School tours

Lord Mayor Reynolds hosts Town Hall tours for school groups to assist students in understanding the history of the city and how local government operates. The tour includes time in the Council Chamber where students participate in a 'mock' Council meeting. This gives them first-hand experience of how decisions that impact residents of Hobart are made, as well as the opportunity to learn about the role of local government in Australian democracy.

During the year, we were pleased to host 13 groups from Fahan School, Sacred Heart College, Lenah Valley Primary School, South Hobart Primary School, Waimea Heights Primary School and Goulburn Street Primary School.

### **Children's Mayor Program**

In 2024, we 'elected' the City's fourth Children's Lord Mayor and Children's Deputy Lord Mayor. The program, as part of National Children's Week, encourages Hobart primary school students to engage in and articulate their perspectives on local issues, as well as giving them a taste of what it's like to work at the Town Hall.

Students from schools across the city were invited to write their own manifestos as to what they would do if given the role of Lord Mayor of Hobart. Lord Mayor Reynolds hosted a morning tea/formal reception for these future leaders at the Hobart Town Hall, where the winning manifestos were read. Twelve-year-old **Lola Mennitz from The Friends School** was declared the 2024 Children's Lord Mayor for her submission *"One side to the other, a matter of time before you decide"*, a proposed ferry service to encourage greater connectivity in Hobart's public transport services, one that would complement Metro Bus Services by connecting both sides of the river as well as the northern and southern suburbs.

Joining Lola as the Children's Deputy Lord Mayor was **Alice Plimpton**, also 12 years old, from **Lansdowne Crescent Primary School**. Alice's submission *"Let's paint our city with endangered flora and fauna to brighten and educate"* advocated for the creation of artistic murals around Hobart centred around local endangered species to raise awareness of our city's unique natural wonders as well as brighten up public spaces.

Sixteen manifestos were received from students attending a range of public and private schools within the Hobart local government area.

Upon request, Lord Mayor Reynolds hosts receptions for clubs and organisations to celebrate significant occasions or national or cultural days. These receptions are held in the Lord Mayor's Court Room at the Hobart Town Hall.

# Liaise with the General Manager

"to lead and participate in the appointment, and the monitoring of the performance, of the general manager and to liaise with the general manager on:

- the activities of the Council and the performance and exercise of its functions and powers;
- the activities of the general manager and the performance and exercise of powers in supporting the Council."

The Lord Mayor led the recruitment process to appoint Michael Stretton, former Launceston City Council General Manager, to the role of City of Hobart CEO in October 2023. Mr Stretton commenced with the City of Hobart in February 2024.

Throughout 2024, the Lord Mayor has liaised with Mr Stretton on the Council's activities and monitored the performance and exercise of powers of the CEO in supporting the City of Hobart's elected officials.
