## Terms and conditions

### The following conditions and restrictions apply to this permit:

1. The wishes of members of the public are respected. This permit does not provide exclusive use of the nominated location/s, and permit holders must not restrict members of the public from accessing the location or facilities in any way.
2. The Council is indemnified against any injury or damage to person or property as a direct result of the proposed activity.
3. No added risk or unnecessary disturbance to passers-by or businesses is caused by the proposed activity, and every effort is made to minimise disruption.
4. If required, a traffic management plan must be sought and approved before the scheduled activity. A traffic management plan is required for any planned road closures or disruption to traffic flow.
5. Film locations must be left tidy and all rubbish removed.
6. The applicant is required to notify nearby residents and businesses of filming operations and make every effort to minimise disruption of regular activities.
7. Filming and associated activities must not damage City of Hobart property or infrastructure.
8. Any direction issued by a City of Hobart officer must be followed.
9. This permit is subject to the General Manager's discretion, and can be cancelled or amended at any time by the General Manager or authorised delegate.
10. This permit does not include any parking concessions. If the activity is to take place in areas with controlled parking restrictions (e.g. meters, voucher machine time limits), these restrictions are to be adhered to at all times unless separate approval has been granted.
11. If filming at a private property, permission must be sought from property owners.
12. The applicant shall have and maintain for the period of the permit, a policy of insurance against risk to the public, and such a policy to be of a minimum amount of \$20 million in respect of any one claim. The amount insured may vary depending on the size, nature and risk associated with the filming project. A Certificate of Currency outlining the nature and level of insurance cover must accompany the application. The applicant must immediately notify the relevant insurers and Council in writing of any occurrence or accident likely to give rise to a claim under the insurance policy and give all information and assistance as may be reasonably practicable in all circumstances.
13. The applicant is responsible for any damage to property in the area of the issued permit, or damage as a result of the event, and undertakes to promptly compensate the Council upon request.
14. This permit only applies to the public area within the Hobart City Council municipal area during the stated period, excluding any land owned or managed by other authorities, including waterfront areas managed by TasPorts or other parties.
15. If any changes impact on the approved time, dates or proposed activity, a permit amendment will be required. Amendments are to be requested in writing with detail of the proposed changes.
16. The applicant is responsible for ensuring the proposed filming activity is compliant with all applicable state and local laws, rules and regulations.
17. The applicant will provide an appropriate COVID Safe Plan on request, and agrees to adhere to any current Federal, State and Local Government health and safety guidelines relating to physical distancing, gathering restrictions and any other relevant safety and hygiene measures for the duration of the permit.
18. Where applicable, the applicant will provide any relevant accreditations for drone use from the Civil Aviation Safety Authority (CASA) on request, and agrees to the standard operating conditions and rules that apply for drone use within Australia.
